Lot owners are responsible for removing decorations they wish to keep, prior to these dates. Decorations that become unsightly or out of season will be discarded.

RULES & REGULATIONS

DECORATIONS

Artificial flowers only in the Mausoleums.

One American flag per grave for Memorial Day. Flags will be removed as per flag code.

One standard floral saddle is welcome on a monument.

Two non-ferrous, composite vases per monument base.

Bronze vases should be returned to the flush inverted position when not in use and during the winter months for safety purposes.

Any article placed in the cemetery in violation of the rules and regulations may be removed and discarded without notice.

Violations include but are not limited to:

Temporary Markers

Flower planters, boxes & pots

Plantings of any kind

Urns

Statues and Figurines

Corner posts

Glass of any kind

Toys and stuffed animals

Trellises

Solar lights

Wooden or plastic crosses

Flags & Flag Holders

Fraternal symbols

Shepherd hooks

Crushed stone or wood chips

CARS & BIKES

Speeds limits not to exceed 20 miles per hour.

No bicycles or motorcycles are permitted, unless they are attending a service.

MEMORIAL GUIDELINES & REGULATIONS

All lot owners or anyone duly authorized to act for, or on behalf of lot owner(s) in accordance with Section 8 of the Religious Corporation Law of the State of New York, must secure from the Cemetery written approval of the design, size and lettering style.

Section 8 of the Religious Corporations Law of the State of New York

TITLE & RIGHT TO LOT OWNER

The possession of a Certificate of Interment Rights or Deed by anyone other than the original purchaser does not guarantee ownership of or the right to use graves. Upon the death of the purchaser, the ownership of the lot is governed by Section 8 of the Religious Corporations Law of the State of New York: "Lots in such cemeteries shall be held indivisible, and upon the decease of a proprietor of such lot the title thereto shall descend to his heirs-at-law or devisees subject, however, to the following limitations and conditions: If he leaves a widow and children, they shall have in common the possession, care and control of such lot during her life. If he leaves a widow and no children, she shall have possession, care, and control of such lot during her life. If he leaves children and no widow, they or the survivor of them, shall in common have the possession, care and control of such lot during the life of the survivor of them. The parties having such possessions, care and control of such lot during the term, thereof may erect a monument and make other permanent improvements thereon. The widow shall have the right of interment, for her own body in such lot, or in a tomb in such lot and a right to have her body remain permanently interred or entombed therein, except that her body may be removed therefrom to some other family lot or tomb with the consent of her heirs. At any time when more than one person is entitled to the possession, care or control of such lot, the persons so entitled thereto shall designate in writing to the religious corporation which of their number shall represent the lot, and on their failure to designate, the board of trustees or directors of the corporation shall enter of record which of said parties shall represent the lot, while such failure continues. The widow may at any time release her right in such lot, but no conveyance or devise by any other person shall deprive her of such right."

APPROVALS

Only approved Memorials may be installed.

Contact the cemetery office for a Memorial Installation Application before ordering a memorial.

Each section of each cemetery may have specific rules and regulations, or unique provisions. Any memorial with a non-religious design must also contain an appropriate religious design. Designs deemed offensive will be denied.

Submit the completed installation application with signature of lot owner and sketch/artwork and payment to the cemetery office for approval.

The cemetery is not responsible for memorials purchased without prior written approval.

Only one marker allowed per grave.

VETERAN MEMORIALS

Veteran markers must conform to Cemetery regulations and specifications.

The VA requires the signature of a Cemetery official certifying that the marker is permitted on the unmarked grave of the deceased.

VA forms 40-1330 and DD-214 should be signed and returned to the cemetery with the completed Memorial Installation Application and installation fee.

AUTHORIZED VENDORS

Authorized Vendors with proper Certificates of Insurance on file at the cemetery office may install memorials.

The cemetery does not accept deliveries from anyone other than Authorized Vendors.

Foundations are generally constructed as time and weather permits (Spring, Summer & Fall).

Monuments and grave markers remain the property of the lot owner. The Cemetery is not liable for maintenance and repair of monuments and grave markers.

Markers

1. If an infant is interred in the same grave with an adult, an infant marker is permitted.
2. Only bronze markers are permitted in shrine sections and require a granite base.
3. All vases must be round and be made of bronze containing at least 85% copper.

Size of Markers:

Monument Section:

- Monument Flush Granite
24" x 12" x 4" (or) 20" x 10" x 4" (Infant)
- Flush Bronze (Monument Lot)
24" x 14"
- Veteran or matching 24" x 12" w/o vase
- Infant 18" x 9" or 16 x8

Shrine Section:

- Flush Bronze
24" x 14" or 16" x 24"
- Double 44" x 14"

Monuments

1. Only one monument is allowed per monument lot.
2. Completely axed bases are not permitted. Only margin bases are allowed.
3. The minimum width of any base must be 8 inches unless otherwise permitted. The minimum width of any die must be 8 inches unless otherwise permitted.
4. For crosses, the cut out shall not extend below the horizontal arms of the cross. A 5-foot-high cross with a 10-inch base is allowed on a four grave lot provided the overall height does not exceed 6 feet. Trinity bases on a cross shall be cut solid. The width of the base must be at least 16 inches.

Monument sizes are as follows:

6 grave	3'0" x 1'2"	5'0" x 1'6"	36" to 46"
8 grave	3'6" x 1'2"	6'0" x 1'8"	36" to 46"
12 grave	4'6" x 1'4"	7'0" x 2'0"	36" to 54"
